## MINUTES

### Meeting to Order (Mike Huntley)

- Welcome – Call to Order at 7:06 pm

### Treasury Report (Mike Huntley)

- Recent disbursements include payments for technology and teacher aides.

### Principal's Report (Pam Coughlin)

- The district must cut \$13.5 million from the budget this year. Three years ago \$3 million was cut, followed by \$5 million and then \$8 million last year.
- On 2/9, the board will be voting on the cuts. 100 teachers throughout the district may be laid off. The district may choose to cut more heavily in other areas, however, and not as deeply in its staff.
- Last year we did not have any teacher layoffs, the district released temporary teachers only.
- The layoffs will be based on seniority. Teachers who were hired in 2004 or later may be affected. 9 teachers in our school received Letters of Verification, which is the first step. It does not mean its final; it just means they are in the pool of potential layoffs.
- In addition, class size for the lower grades will increase to 24 students. This means we will lose 2 primary classes and will most likely have a K/1 combo and a 2/3 combo.

- Because our district receives most of its money from property taxes and not the state, we are not affected as much as other districts.

### **Spring Fundraiser/Art Walk (Sharon Zablan)**

- The Art Walk will take place on May 22<sup>nd</sup> at the ENC.
- Nanci will be meeting with the ENC on 2/9 to go over the contract/details.
- The Swinging Tiki's (Tim Carr) will provide the music and TK Burgers will provide the food.

### **January Bowling Fundraiser (Debby Wienser)**

- The event was held on January 30<sup>th</sup>, 21 couples attended for a profit of \$2,475.
- Our only expense was the bus.
- It was a lot of fun, very organized, plenty of food.
